RESOLUTION NO. 10023

WHEREAS, the Commission on Elections is mandated to conduct and ensure the holding of a free, orderly, honest, peaceful, credible automated national and local elections on May 09, 2016;

WHEREAS, for the said purpose, there is an imperative need to provide sufficient uninterrupted electrical power supply during the critical days of the elections;

NOW, THEREFORE, the Commission on Elections, pursuant to the powers vested in it by the Constitution, the Omnibus Election Code, Republic Act No.9369 and other related election laws, **RESOLVED**, as it hereby **RESOLVES**, as follows:

SECTION 1. Deputization. — The Department of Energy, the National Electrification Administration, the National Power Corporation, the National Grid Corporation of the Philippines, and the Local Electrification Cooperatives are hereby deputized in connection with the conduct of the May 09, 2016 national and local elections.

SEC. 2. Duties and Functions. — As such deputies, they shall have the following duties and functions:

1. Provide and maintain stable and continuous nationwide electric power requirements starting from May 02, 2016 until the termination or conclusion of the canvassing of votes and the proclamation of the winning candidates;
2. Perform such other duties and functions as the Commission may provide.



The Executive Director shall implement this Resolution.
