RESOLUTION NO. 10765

WHEREAS, the Commission on Elections, in its steadfast commitment to ensure an efficient and speedy disposition of election cases, has been constantly updating its own Rules of Procedure pursuant to the powers granted to it by Article IX-C of the 1987 Constitution;

WHEREAS, there is a need to supplement COMELEC Resolution Nos. 9914 and 9929 in order to guarantee this Commission's incessant and firm dedication to professionalism and efficiency to the parties and to the public;

NOW, THEREFORE, in view of the foregoing, the Commission **RESOLVED**, as it hereby **RESOLVES**, to promulgate the following rules, further amending and enhancing COMELEC Resolution Nos. 9914 and 9929:

I. GENERAL PROVISIONS

1. Within a period of forty-five (45) days from the retirement of a Commissioner, the Member-Commissioners of the Former First Division and the Former Second Division designated pursuant to COMELEC Minute Resolution No. 22-0101¹ and similar Minute Resolutions there after shall complete and windup the resolution of the cases previously raffled to the remaining Members as *ponente*. Provided that for the year 2022, the forty-five-day (45) period shall be reckoned from the effectivity of this Resolution.
2. All pending cases assigned to the retired Chairperson/Commissioners shall be inventoried and thereafter raffled among the remaining members of the Commission (*En Banc*) or the Former Divisions, as the case may be, unless otherwise directed by the Chairperson/Presiding Commissioners.
3. After the expiration of the forty-five (45) day period or upon the assumption to office and designation as members of the regular divisions of new Commissioners, whichever comes first, the Former First Division and Former Second Division shall be automatically dissolved.

4. In case a Commissioner is reassigned to another Division, the reassigned Commissioner shall bring the pending cases raffled to him/her as *ponente* in the previous Division to the Regular Division where he/she may be reassigned.

II. MISCELLANEOUS PROVISIONS

1. All rules and regulations inconsistent with the provisions of this Resolution are hereby amended and repealed accordingly.
2. The provisions of this Resolution shall be deemed applicable to similar situations which shall arise after its effectivity.
3. The Policy Study Group is hereby directed to codify all the resolutions relating to the protocol on electronic raffle of cases and incorporate the same in the Comelec Rules of Procedure.
4. This Resolution shall be effective immediately upon publication.
5. The Education and Information Department (EID) is hereby directed to cause the publication of this Resolution in two (2) daily newspapers of general circulation in the Philippines. The Information and Technology Department is likewise directed to publish the same in the official COMELEC website (www.comelec.gov.ph).
