RESOLUTION NO. 10963-A

WHEREAS, on 10 January 2024 the Commission *En Banc* approved Resolution No. 10963, *Rules and Regulations on the Conduct of the System of Continuing Registration of Voters for the National and Local Elections*.

WHEREAS, Section 3 of Resolution No. 10963 set the deadline for online filing of application for reactivation, reactivation with transfer of registration within or with correction of entries, reactivation with transfer within and correction of entries and reactivation with updating of records of Senior Citizens (SCs) and Persons with Disabilities (PWDs) to until September 7, 2024.

WHEREAS, in light of the significant number of deactivated voters who have not yet applied for reactivation, the Commission *En Banc* recognizes the necessity of extending said deadline to allow more Filipinos to avail the online filing of application for reactivation.

NOW THEREFORE, after due deliberation, the Commission *En Banc*, by virtue of the powers vested in it by the Constitution, the Omnibus Election Code, the Administrative Code of 1987 and other relevant statutes, hereby **RESOLVES** to **EXTEND** the deadline of online filing of application for reactivation to **September 25, 2024** and to **AMEND** Section 3 of COMELEC Resolution No. 10963 to read as follows:

"SEC. 3. Schedule and Conduct of Registration of Voters

xxx

Online filing of application for reactivation; reactivation with transfer of registration within or with correction of entries; reactivation with transfer within and correction of entries; and reactivation with updating of records of SCs and PWDs, pursuant to Resolution No. 10715, shall be continuously received by the OEOs, through their official email addresses **until September 25, 2024.**"

Further, all prior Resolutions on this matter are hereby AMENDED.

Let the Election and Barangay Affairs Department and the field offices implement this Resolution.

Let the Education and Information Department cause the publication of this Resolution in two (2) daily newspapers of general circulation in the Philippines and let the Information Technology Department post this Resolution in the official COMELEC website.
