**RESOLUTION NO. 11004**

**WHEREAS**, on June 3, 2024, the Commission in partnership with the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) *Participate* conducted a "Multiparty Democracy Summit - BARMM", which was attended by various election stakeholders and BARMM regional political parties, to discuss the salient points of the Bangsamoro Electoral Code (BEC), and its Implementing Rules and Regulations (IRR) under Resolution No. 10984.

**WHEREAS**, the update on the preparation for the 2025 BARMM Parliamentary Elections, as well as the period for the conduct of certain activities in the BARMM pursuant to Resolution No. 10987 were also discussed during the summit.

**WHEREAS**, in view of the tight schedule for the conduct of certain activities under Resolution. No. 10987 as raised by the BARMM regional political parties, there is a need to reasonably adjust the periods stated therein.


**NOW THEREFORE**, after due deliberation, the Commission *En Banc*, by virtue of the powers vested in it by the Constitution, the Omnibus Election Code, the Administrative Code of 1987 and other relevant statutes, hereby **RESOLVES**, to **EXTEND** the period for the conduct of certain activities in the BARMM; Resolution No. 10987, entitled, "In the Matter of the Period to File Petitions for Registration and/or Accreditation and Manifestation of Intent to Participate in the Parliamentary Elections (MIP-PES) of Regional Parliamentary Political Parties and Parliamentary Sectoral Organizations for the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM)", is amended as follows:
