RESOLUTION NO. 11070

WHEREAS, on August 28, 2024, the Commission on Elections (COMELEC) promulgated Resolution No. 11045 entitled "Rules and Regulations Governing: 1) Political Conventions; 2) Submission of Nominees of Groups or Organizations Participating Under the Party-List System of Representation and Parliamentary System in the BARMM; and 3) Filing of Certificates of Candidacy and Nomination of and Acceptance by Official Candidates of Registered Political Parties or Coalitions of Political Parties in Connection with the May 12, 2025 National and Local Elections and BARMM Parliamentary Elections";

WHEREAS, Section 36 of the said Resolution provides that candidates for Member, Sangguniang Panlalawigan shall file their Certificates of Candidacy (COCs) with the concerned Office of the Provincial Supervisor (OPES);

WHEREAS, the said Resolution does not provide for the venue of filing of COCs for cities which are entitled to their own representatives in the Sangguniang Panlalawigan;

NOW, THEREFORE, the COMELEC, pursuant to the powers vested in it by the Constitution, the Omnibus Election Code, and other election laws, **RESOLVES**, as it hereby **RESOLVED**, to promulgate the following supplemental to Resolution No. 11045:

SECTION 1. For cities which are entitled to their own representatives in the Sangguniang Panlalawigan, the candidates shall file their COCs with the concerned Office of the Election Officer (OEO).

SECTION 2. Effectivity. - This Resolution shall take effect immediately upon promulgation.

SECTION 3. Publication and Dissemination. - The Information Technology Department shall cause the publication of this Resolution in the website of the COMELEC, and the Education and Information Department shall cause its dissemination to all field officials of the COMELEC and to the general public.
