

RESOLUTION NO. 11071

WHEREAS, pursuant to Section 2 (i), Rule 2, of Resolution No. 9366 in relation to Section 6 (8) of Republic Act No. 7941 or "Party-List System Act," the Commission may, *motu proprio* or upon verified complaint of any interested party, refuse or cancel, after due notice and hearing, the registration of any national, regional or sectoral party, organization or coalition for failure to participate in the last two (2) preceding elections or failure to obtain at least two per centum (2%) of the votes cast under the party-list system in the two preceding elections for the constituency in which it was registered;

WHEREAS, in *Philippine Guardians Brotherhood, Inc. vs. Comelec*¹ the Supreme Court clarified that Section 6 (8) of R.A. No. 7941 provides for two (2) separate grounds for delisting, and that these grounds cannot be mixed or combined to support delisting. It further ruled that groups that fail to obtain at least two (2) per centum refers to party-list groups that failed to obtain at least two percent of the votes cast for the party-list system in the last two preceding elections **and** failed to obtain a seat in the second round of seat allocation for the party-list system in the last two preceding elections.

WHEREAS, the following party-list groups, organizations, and coalitions failed to participate in the last two (2) preceding elections:






cancellation or disqualification against any party, organization, or coalition and/or its nominees for the 12 May 2025 National and Local Elections.


