**RESOLUTION NO. 11073**

**WHEREAS**, by virtue of COMELEC Resolution No. 11046, the period for filing of Petitions Against Nuisance Candidates shall be within five (5) days from the last day of filing Certificates of Candidacy (COC).

**WHEREAS**, the last day to file COC is on 08 October 2024. The fifth (5<sup>th</sup>) day therefrom is on 13 October 2024 which falls on a Sunday. The next working day, which is 14 October 2024, is deemed as the last day for filing Petitions Against Nuisance Candidates.

**WHEREAS**, in view of the issuance of Memorandum Circular No. 66 dated 10 October 2024 by the Office of the President, work in all COMELEC offices in Manila and Pasay has been suspended on 14 and 15 October 2024.

**NOW THEREFORE**, after due deliberation, the Commission *En Banc*, by virtue of the powers vested in it by the Constitution, the Omnibus Election Code, the Administrative Code of 1987 and other relevant statutes, hereby **RESOLVES** to **EXTEND** the last day for filing Petitions Against Nuisance Candidates until **16 October 2024**,

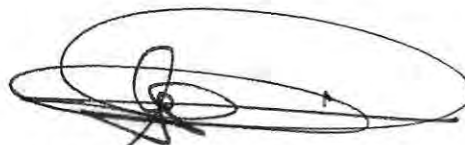
the next working day following the 14 and 15 October 2024 holidays declared by the Office of the President.

This Resolution shall take effect immediately after publication.

Let the Education and Information Department cause the publication of this Resolution in two (2) daily newspapers of general circulation in the Philippines and its widest dissemination. The Information Technology Department is likewise directed to post this Resolution in the official COMELEC website.

Let the Office of the Clerk of the Commission implement this Resolution.

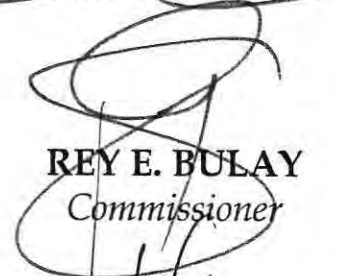

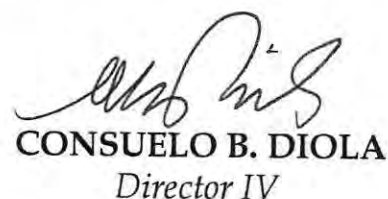
