RESOLUTION NO. 11074

WHEREAS, the Commission on Elections has the power to enforce and administer all laws and regulations relative to the conduct of an election, plebiscite, initiative, referendum, and recall pursuant to Section 2 (1), Article IX-C of the 1987 Constitution;

WHEREAS, Resolution No. 11068, entitled "*Rules and Regulations on the Conduct of Raffle of Party-list Groups to Determine the Order of Listing in the Official Ballot in Connection with the 2025 National and Local Elections*," was promulgated on 25 September 2024, which provides for the issuance of a list of all party-list groups, organizations or coalitions allowed to participate in the raffle;

NOW, THEREFORE, the Commission **RESOLVED** as it hereby **RESOLVES**, to promulgate the following in relation to the participation of party-list groups in the conduct of raffle to determine the order of their listing on the official ballot in connection with the 2025 National and Local Elections:

SECTION 1. Party-list Groups Eligible to Participate in the Raffle. -
The following party-list groups, organizations, and coalitions shall be allowed to participate in the raffle on 18 October 2024, 9 AM, for purposes of determining their order of listing on the official ballot:

SECTION 2. *Final Listing.* - A final listing of the party-list groups, organizations, and coalitions in the order of the result of the raffle shall be published and posted within fifteen (15) days after the conduct of the raffle, in two (2) newspapers of general circulation and in the official website of the Commission.

Participation in the raffle is without prejudice to the disposition of any Temporary Restraining Order (TRO) which the Supreme Court may issue after the publication of the final list and before finalization of the ballot face. Participation is likewise without prejudice to the exclusion on the official ballot, if applicable, for failure to file a Certificate of Nomination and Certificate of Acceptance of Nomination.

SECTION 3. *Implementation.* - The Office of the Clerk of the Commission (OCOC), Information Technology Department (ITD), Education and Information Department (EID), Office of the Commission Secretary, and Law Department are hereby directed to implement this Resolution.

The EID and the ITD shall cause the publication and posting of this Resolution in two (2) newspapers of general circulation and in the official website of the Commission, respectively.

SECTION 4. Effectivity. - This Resolution shall take effect immediately upon publication in two (2) newspapers of general circulation and in the official website of the Commission.


