RESOLUTION NO. 11086-A

WHEREAS, on 09 December 2024, the Commission on Elections promulgated COMELEC Resolution No. 11086 entitled, "Rules and Regulations Implementing Republic Act No. 9006, otherwise known as the 'Fair Elections Act' in connection with the 12 May 2025 National, Local, & Bangsamoro Parliamentary Elections.

WHEREAS, Section 10 of COMELEC Resolution No. 11086 reads as follows:

*"SECTION 10. Request for Authority to Use Other Election Propaganda. - Any person seeking authority to use other forms of election propaganda not covered by those enumerated in Section 6 hereof and not prohibited by law may file with the COMELEC En Banc, through the Commission Secretary, a request describing the election propaganda sought to be authorized with samples thereof."*

WHEREAS, in view of the exigency of service, Section 10 of COMELEC Resolution No. 11086 shall be amended to designate the Office of the Chairman as the recipient of requests to use other election propaganda, along with the submission of the actual samples of said election propaganda.

NOW, THEREFORE, the Commission on Elections, by virtue of the powers vested in it by the Constitution, the Omnibus Election Code, and other pertinent laws, **RESOLVED**, as it hereby **RESOLVES** to **AMEND** Section 10 of COMELEC Resolution No. 11086 to read as follows:

*"SECTION 10. Request for Authority to Use Other Election Propaganda. - Any person seeking authority to use other forms of election propaganda not covered by those*

*enumerated in Section 6 hereof and not prohibited by law may file with the COMELEC En Banc, through the Office of the Chairman, a request describing the election propaganda sought to be authorized with samples thereof."*

Let the Education and Information Department cause the publication of this Resolution in two (2) daily newspapers of general circulation in the Philippines and its widest dissemination. The Information Technology Department is likewise directed to post this Resolution in the official COMELEC website.
