Only authorized personnel are allowed to access your personal data. Immediately after the retention period or upon the expiration of the storage period provided by the COMELEC Rules and policies, and laws and regulations, whichever applies, the physical and digital copies of your personal data will be anonymized, deleted, and discarded following the disposition procedures of the COMELEC and the National Archives of the Philippines.
