RESOLUTION NO. 11123

WHEREAS, Section 17 of Republic Act No. 9369¹ provides:

"**Sec. 17** Section 16 of Republic Act No. 8436 is hereby amended to read as follows:

"**SEC. 20. Notice of Designation of Counting Centers.** - The election officer shall post prominently in his/her office, in the bulletin boards at the city/municipal hall and in three other conspicuous places in the city/municipality, the notice on the designated counting center(s) for at least three weeks prior to election day. The notice shall specify the precincts covered by each counting center and the number of registered voters in each of said precincts. The election officer shall also furnish a copy of the notice to the headquarters or official address of the political parties or independent candidates within the same period. The election officer shall post in the Commission website concerned the said notice and publish the notice in the local newspaper. Where the polling place or voting center is also the designated counting center, such information shall be contained in the notice." (emphasis supplied)

WHEREAS, Resolution No. 10999² prescribes the calendar of activities for the periods of certain prohibited acts in connection with the May 12, 2025 National and Local Elections (2025 NLE). **However**, the periods/last day for the following activities were not provided in said Resolution:

² CALENDAR OF ACTIVITIES AND PERIODS OF CERTAIN PROHIBITED ACTS IN CONNECTION WITH THE MAY 12, 2025 NATIONAL AND LOCAL ELECTIONS (NLE), AND BARMM PARLIAMENTARY ELECTIONS

- A. Last day for the Election Officers to: (1) post copies of Project of Precincts (POPs); (2) furnish copies of POPs to the official addresses of city/municipal candidates;
- B. Last day for the Provincial Election Supervisors (PESs) to furnish copies of the POPs of cities/municipalities in the province to the official addresses of the concerned candidates for Member, House of Representatives and provincial elective positions;
- C. Last day for the Law Department to furnish copies of the POPs of cities/municipalities to the official addresses of the candidates for national elective positions, including party-list groups participating in the party-list system of representation; and
- D. Last day for the Information Technology Department (ITD), in coordination with the Election and Barangay Affairs Department (EBAD) to post the POPs of the cities/municipalities/districts in the official website of the Commission.

WHEREAS, the calendar of activities for the periods of certain prohibited acts in connection with the December 1, 2025 Barangay and Sangguniang Kabataan Elections (2025 BSKE) is yet to be promulgated.

NOW, THEREFORE, by virtue of the powers vested in it by the 1987 Constitution of the Republic of the Philippines, the Omnibus Election Code (Batas Pambansa Blg. 881), Republic Act No. 9369, and other election laws, the Commission on Elections **RESOLVED** as it hereby **RESOLVES**:

1. In accordance with Section 17 of Republic Act No. 9369 requiring that **notice must be posted at least three weeks prior to election day**, to direct all Election Officer/Acting Election Officer (EO/AEO) that, in lieu of said notice, to instead:
 - a. Post prominently copies of the Project of Precincts (POPs), including any changes made thereto, at the Office of the Election Officer, on the bulletin board of the city/municipality/district hall in three (3) other conspicuous places in the said city/municipality/district, **on or before April 21, 2025 (Monday) for the 2025 NLE**, and **on or before November 10, 2025 (Monday) for the 2025 BSKE**;
 - b. Furnish copies of said POP, including any changes made thereto, to the official addresses of the city/municipality/district candidates, **on or before April 21, 2025 (Monday) for the 2025 NLE**, and **on or before November 10, 2025 (Monday) for the 2025 BSKE**;
2. To direct all Provincial Election Supervisors (PESs) to furnish copies of the POPs of cities/municipalities/districts in the province to the official addresses of the concerned candidates for Member, House of Representatives and provincial elective positions, including any changes made thereto, **on or before April 21, 2025 (Monday) for the 2025 NLE**, and **on or before November 10, 2025 (Monday) for the 2025 BSKE**;

3. To direct all Regional Election Directors (REDs) to monitor and ensure implementation of Item Nos. 1 and 2;
4. To direct the Law Department to furnish copies of the POPs of cities/municipalities to the official addresses of the candidates for national elective positions, including party-list groups participating in the party-list system of representation **on or before April 21, 2025 (Monday) for the 2025 NLE**, and **on or before November 10, 2025 (Monday) for the 2025 BSKE**;
5. To direct the Information and Technology Department (ITD), in coordination with the Election and Barangay Affairs Department (EBAD), both to post the POPs of the cities/municipalities/districts in the official website of the Commission, **on or before April 21, 2025 (Monday) for the 2025 NLE**, and **on or before November 10, 2025 (Monday) for the 2025 BSKE**.

Let the Election and Barangay Affairs Department, Information Technology Department, Law Department, Offices of the Regional Election Directors (OREDs), Offices of the Provincial Election Supervisors (OPESs), and the Offices of the Election Officers (OEOs) implement this Resolution.
