25-0167. IN THE MATTER OF THE EVALUATED ONLINE CAMPAIGN PLATFORM REGISTRATIONS OF SENATORIAL ASPIRANTS AND PARTY- LIST GROUPS

This pertains to the Memorandum dated February 3, 2025 of Director John Rex C. Laudiangco, Education and Information Department, and Chairperson, Task Force KKK sa Halalan, as endorsed by Commissioner Nelson J. Celis, relative to the Evaluated Online Campaign Platform Registrations of Senatorial Aspirants and Party-list groups.

The Memorandum of Director Laudiangco reads:

"Pursuant to Section 6, Article III of COMELEC Resolution No. 11064, as amended, all social media accounts and digital campaign platforms for registration to the COMELEC shall be submitted and evaluated by the EID, and subsequently reviewed by the Task Force KKK sa Halalan. Thereafter, the Task Force KKK sa Halalan shall make an endorsement and recommendation for approval or denial of the reviewed applications to the Commission En Banc.

In view of the upcoming campaign period for national positions and in compliance to the above provision, we are respectfully transmitting the hereto attached online campaign platform registrations of Senatorial aspirants and Party-List groups as evaluated by the Education and Information Department.

Their compliance status is summarized as follows:

For your reference, enumerated below are the parameters used to determine their compliance during the evaluation by this Department:

COMPLIANT

- With submission of online registration form via Google Forms.
- With complete and correct uploads of required documents on the online registration form.
- With correct and functional URLs (links) of online campaign platforms.
- With transmittal of hardcopy of the required documents and the hardcopies are complete and the same with the documents uploaded on the online registration form.

- *Transmittal of hardcopy of the required documents is within five (5) days from submission of the online registration form.*

PARTIALTY COMPLIANT

- *With submission of online registration form via Google Forms and transmittal of hardcopy of the required documents, but:*
 - *The required documents uploaded and hardcopies are not the same, incorrect, or there are missing required documents on either.*
 - *The transmittal of hardcopy of the required documents is beyond five (5) days from the submission of online registration form. (Filed out of time)*
 - *Any of the transmitted hardcopy is not notarized.*
 - *The social media campaign manager submitted online is different from the social media campaign manager in the hardcopy of the required document transmitted.*

NOT COMPLIANT

- *Failure to submit online registration form via Google Forms from 9 October 2024 until 13 December 2024 and failure to transmit hard copies of the required documents within five (5) days from the submission of online registration form.*
- *With submission of online registration form via Google Forms but no transmittal of hardcopy of the required documents.*
- *With transmittal of hardcopy of the required documents but no submission of online registration form.*
- *With submission of online registration form and transmittal of hardcopy of the required documents but there are no Google Drive links for the uploaded documents.*
- *With submission of online registration form and transmittal of hardcopy of the required documents but the Google Drive links for the uploaded documents are incorrect or restricted or cannot be accessed as of the evaluation date.*
- *With submission of online registration form and transmittal of hardcopy of the required documents but there are no URLs of the online campaign platform in the online registration form submitted.*
- *With submission of online registration form and transmittal of hardcopy of the required documents but the URLs for the online campaign platforms only lead to deactivated/deleted/restricted/ removed/unavailable/taken down accounts, pages, or sites.*
- *Submission and transmittal of all required documents, URLs of online campaign platforms, and other information for purposes of online campaign platforms registration via e-mail or any other means not prescribed by the COMELEC EID pursuant to COMELEC Resolution No. 11064, as amended.*

We are hoping to secure the Commission En Banc's approval or denial of the evaluated and reviewed online campaign platform registrations for Senators and Party-List groups this week.

For your immediate review, appropriate action, and kind approval, please.

The Commission, after due deliberation, **RESOLVED**, as it hereby **RESOLVES**, to **APPROVE** the registrations¹ of the **fully compliant candidates and parties** in the 2025 National, Local and Bangsamoro Parliamentary Elections. The Education and Information Department and the Information Technology

Department are hereby **DIRECTED** to publish all approved registrations in the COMELEC's official social media accounts and in the COMELEC website.

RESOLVED, further, to **DIRECT** the **partially compliant candidates and parties** to fully comply as required in the hereto attached Evaluation by the Education and Information Department.

RESOLVED, lastly, **non-compliant candidates and parties** may remove and/or take down their respective online content, social media platforms and/or accounts. Otherwise, the technology platforms and providers and/or concerned law enforcement agency, through a request from the Task Force KKK sa Halalan, shall cause the removal of the same.

Let the Task Force KKK sa Halalan, the Education and Information Department and the Information Technology Department implement this Resolution and inform the concerned parties of this Resolution.
