## PROCLAMATION NO. 552

EXCLUDING FROM THE OPERATION OF PROCLAMATION NO. 427, DATED NOVEMBER 7, 1931, WHICH ESTABLISHED THE SANTIAGO FARM SCHOOL RESERVATION SITUATED IN THE MUNICIPALITY OF SANTIAGO, PROVINCE OF ISABELA, ISLAND OF LUZON, A CERTAIN PORTION OF THE LAND EMBRACED THEREIN AND RESERVING THE SAME FOR SCHOOL SITE PURPOSES OF THE SANTIAGO VOCATIONAL AND INDUSTRIAL HIGH SCHOOL

Upon recommendation of the Secretary of Environment and Natural Resources, and pursuant to the powers vested in me by law, I, CORAZON C. AQUINO, President of the Philippines, do hereby exclude from the operation of Proclamation No. 427, dated November 7, 1931, which established the Santiago Farm School Reservation situated in the Municipality of Santiago, Province of Isabela, Island of Luzon, a certain portion of the land embraced therein and reserve the same for school site purposes of the Santiago Vocational and Industrial High School under the administration of the Secretary of Education, Culture and Sports, subject to private rights, if any there be, which portion is more particularly described as follows:

Record No. 1496) situated in the Barrio of Calaoacan, Municipality of Santiago, Province of Isabela, Island of Luzon. Bounded on the NW., along lines 23-24-25, by Port. Mons. 15 x 60 Cms. bearings true; date of the original survey. September 1924-February 1932 and that of the segregation survey was executed by Antero Dirige, Geodetic Engineer, on September 15, 19. and October 23-24, 1978 and approved on November 29, 1978.

NOTE: This lot is equivalent to Lot 22958, Cad-211, Santiago Cadastre.
