PROCLAMATION NO. 264

ESTABLISHING AS UMIRAY RIVER WATERSHED RESERVATION FOR PURPOSES OF PROTECTION, MAINTENANCE, AND IMPROVEMENT OF ITS WATER YIELD AND TO PROVIDE RESTRAINING MECHANISM FOR INAPPROPRIATE FOREST EXPLOITATION AND DISRUPTIVE LAND-USE, A CERTAIN PARCEL OF LAND OF THE PUBLIC DOMAIN SITUATED IN THE MUNICIPALITY OF GENERAL NAKAR, PROVINCE OF QUEZON, MUNICIPALITY OF NORZAGARAY, PROVINCE OF BULACAN, AND MUNICIPALITY OF MONTALBAN, PROVINCE OF RIZAL, ISLAND OF LUZON, PHILIPPINES

Upon recommendation of the Secretary of Environment and Natural Resources and pursuant to the powers vested in me by law, I, FIDEL V. RAMOS, President of the Philippines, do hereby withdraw from entry, sale, disposition, or settlement and set aside as Umiray River Watershed Reservation, subject to private rights, if any there be, and to the operations of previous proclamations reserving any portion thereof for specific purposes and to the implementation of socially-oriented projects and other forestry development programs consistent with the objectives of the proclamation as maybe determined by the Secretary of Environment and Natural Resources, a certain parcel of land of the public domain located in the municipality of General Nakar, Province of Quezon, municipality of Norzagaray, Province of Bulacan and Municipality of Montalban, province of Rizal, as shown in the Watershed Map No. 111 with the following descriptions:

Beginning at point "1" on the map, a point designated as corner "1", is located S 67°00' W, 5,875 meters from the junction of Umiray and Surmag River;

Thence N 11°30' E, 695 meters to corner 2, a stake on top of ridge;

Thence N 34°10' W, 605 meters to corner 3, a stake on top of ridge;

Thence N 16°10' E, 1,530 meters to corner 4, a stake on top of slope;

Thence N 73°00' E, 720 meters to corner 5, a stake on top of ridge;

Thence N 43°00' E, 1,450 meters to corner 6, a stake on the ground;

Thence S 80°20' E, 1,880 meters to corner 7, a stake at peak elevation 970 meters;

Thence S 46°40' E, 2,885 meters to corner 8, a stake on top of ridge;

Thence N 78°40' E, 2,045 meters to corner 9, a stake on the ground;

Thence N 66°20' E, 2,820 meters to corner 10, a stake on top of ridge;

Thence S 82°10' E, 3,190 meters to corner 11, a stake on peak elevation 796 meters;

Thence S 14°05' W, 1,532 meters to corner 13, a stake on top of ridge;

Thence S 69°10' W, 3,279 meters to corner 14, a stake on top of ridge;

Thence S 10°25' E, 4,944 meters to corner 15, a stake on top of ridge;

Thence S 58°00' W, 1,536 meters to corner 16, a stake on top of ridge;

Thence S 29°25' E, 2,254 meters to corner 17, a stake on top of ridge;

Thence S 13°05' W, 1,318 meters to corner 18, a stake on top of ridge;

Thence S 38°25' E, 1,577 meters to corner 19, a stake on the ground;

Thence S 18°00' W, 2,681 meters to corner 20, a stake on the ground;

Thence N 63°30' W, 916 meters to corner 21, a stake on the ground;

Thence N 51°50' W, 1,274 meters to corner 22, a stake on the ground;

Thence N 20°45' E, 1,255 meters to corner 35, a stake on the ground;

Thence N 05°20' E, 2,372 meters to corner 36, a stake on peak of Mt. Munong;

Thence S 77°15' W, 812 meters to corner 37, a stake on peak of Mt. Macatuhol;

Thence N 29°35' W, 1,070 meters to corner 38, a stake on the ground;

Thence N 35°15' E, 1,350 meters to corner 39, a stake on the ground;


Thence N 33°15' W, 1,195 meters to corner 40, a stake on peak of Mt. Enamong elevation 1,015 meters;

Thence N 18°26' W, 1,141 meters to corner 1, the point of beginning containing an area of SIXTEEN THOUSAND SEVEN HUNDRED TWENTY TWO AND 75/100 (16,722.75) HECTARES, more or less.


The area covered by the watershed reservation shall be under the administrative jurisdiction, supervision, and control of the Department of Environment and Natural Resources, through its Forest Management Bureau, in coordination with other agencies of the government, with the objective of maintaining its usefulness as a source of water for domestic use, irrigation, and other forestry purposes.
