PROCLAMATION NO. 936

RESERVING CERTAIN PARCELS OF LAND OF THE PUBLIC DOMAIN,  
SITUATED IN THE CITY OF OLONGAPO, ISLAND OF LUZON, FOR  
THE USE OF THE CITY OF OLONGAPO

Upon recommendation of the Secretary of Environment and Natural Resources and pursuant to the authority vested in me by law, **I, FIDEL V. RAMOS**, President of the Republic of the Philippines, do hereby withdraw from sale, entry, disposition or settlement and reserve for the use of the City of Olongapo as municipal building, slaughterhouse, market, school, hospital and public plaza site purposes, subject to private rights, if any there be, certain parcels of land of the public domain, situated in the City of Olongapo, Island of Luzon, which parcels of land are more particularly described as follows:
