PROCLAMATION NO. 278

DECLARING DINADIWAN RIVER WATERSHED FOREST RESERVE
SITUATED IN THE MUNICIPALITY OF DIPACULAO, PROVINCE OF
AURORA AS PROTECTED AREA PURSUANT TO REPUBLIC ACT 7586
(NIPAS ACT OF 1992) AND SHALL BE KNOWN AS DINADIWAN
RIVER PROTECTED LANDSCAPE

Upon the recommendation of the Secretary of Environment and Natural Resources, and pursuant to the powers vested upon me by law, I, **JOSEPH EJERCITO ESTRADA**, President of the Philippines, do hereby set aside and declare **Dinadiwan River Watershed Forest Reserve** consisting of a parcel of land situated in the Municipality of Dipaculao, Province of Aurora, as Protected Area under the category of **Protected Landscape**, subject to private rights and without prejudice to the rights of the indigenous peoples as provided for in R. A. No. 8371, DENR Administrative Order 93-02 and other related rules and regulations, if any, as described in DENR NIPAS Map R-4A-10.

Bounded on the North by forestland; on the South by forestland; on the East by forestland and Dinadiwan Bay and on the West by forestland. The Dinadiwan River Protected Landscape begins at a point marked "1" on the map which is at the mouth of Dinadiwan River thence;



The area shall be under the administrative jurisdiction of the DENR and shall be administered in accordance with the provisions of the NIPAS Act of 1992 and its implementing rules and regulations.
