PROCLAMATION NO. 669

RESERVING FOR SCHOOL SITE PURPOSES OF THE IHAN NATIONAL HIGH SCHOOL, A CERTAIN PARCEL OF LAND OF THE PUBLIC DOMAIN SITUATED AT IHAN, KIBLAWAN, PROVINCE OF DAVAO DEL SUR, ISLAND OF MINDANAO

Upon recommendation of the Secretary of Environment and Natural Resources, and by virtue of the powers vested in me by law, **I, GLORIA MACAPAGAL-ARROYO**, President of the Republic of the Philippines, do hereby withdraw from sale or any other form of disposition or settlement and reserve for school site purposes of the Ihan National High School, under the administration of the Department of Education, a certain parcel of land of the public domain containing an area of **FIFTEEN THOUSAND (15,000) SQUARE METERS**, situated at Ihan, Kiblawan, Province of Davao del Sur, subject to private rights, if there be any, and to final survey, which portion of land is more particularly described as follows:

IHAN NATIONAL HIGH SCHOOL SITE
(Lot 1075-A, Csd-112406-011440)

A PARCEL OF LAND (Lot 1075-A, Csd-112406-011440), situated in Barangay Ihan, Municipality of Kiblawan, Davao del Sur.

Bounded on the Northeast along lines 1-2-3 by Lot 1075-B, Csd-112406-011440; along line 3-4 by Lot 1074, Pls 632, Ext. (Lot 124-A, Csd-11-007603-D); on the Southeast, along line 4-5; on the Southwest, along lines 5-6-7-8 both by Lot 1075-C, Csd-112406-011440; and on the Northwest, along line 8-1 by Lot 8451, Pls-220, Malalag Public Land Subdivision.

Beginning at a point marked "1" on plan, being N. 67 deg. 34' W., 1204.97 m. from BLLM No. 263, Pls-220, thence:

approved on August 26, 1993.


The tract of land herein shall be non-alienable and shall not be
