PROCLAMATION NO. 1059

AMENDING PROCLAMATION NO. 249 (S.2000) BY RESERVING TWO PARCELS OF LAND IN BARANGAY LIBERTAD, BUTUAN CITY, ISLAND OF MINDANAO, AS THE BUTUAN CITY UPTOWN GOVERNMENT COMPLEX, AND AUTHORIZING ITS TRANSFER TO THE CITY GOVERNMENT OF BUTUAN

Upon the recommendation of the Secretary of the Department of Environment and Natural Resources (DENR) and by virtue of the powers vested in me by law, I **BENIGNO S. AQUINO III**, President of the Republic of the Philippines, do hereby amend Proclamation No. 249 (s. 2000), by reserving two parcels of land in Barangay Libertad, City of Butuan, Island of Mindanao, as the Butuan City Uptown Government Complex, and authorizing the transfer to the City Government of Butuan the said parcels of land, more particularly described as follows, to wit:

LOT A-2-B-1, Psd-13-022535

A parcel of land (Lot A-2-B-1 of the subdivision plan Psd-13-022535, being a portion of Lot A-2-B, Psd-13-015497), situated in Barangay Libertad, Butuan City.

Bounded on the SE., along 1-2 by Road; on the NE., along line 2-3 by National Highway; on the SE., along line 3-4 by B, Pcs-10-001550; on the SW., along lines 4-5-6 by Lot 394, Cad-84; on the SW., along lines 5-6-7 by Lot 395, Cad-84; of the Subdivision Plan; on the NW., along line 8-9 by Lot A-2-A, Psd-13-015497; on the NW., along line 9-10 by Road; on the NE., along line 10-11 by National Highway; and on the NE., along lines 11-12-13-14-15-16-17 by Lot A-1, Psd-13-001143; lines 17-18-19-1 by Lot A-2-B-2, Psd-13-022535.

The parcels of land shall be transferred to the City Government of Butuan on the condition that the said parcels of land shall not be used for any purposes other than government offices.
