PROCLAMATION NO. 201

CREATING AND DESIGNATING A BUILDING WHICH STANDS ON SEVERAL PARCELS OF LAND LOCATED AT NAGA DIVERSION ROAD CORNER ALMEDA HIGHWAY, BARANGAY TRIANGULO, NAGA CITY AS AN INFORMATION TECHNOLOGY CENTER PURSUANT TO REPUBLIC ACT NO. 7916, AS AMENDED BY REPUBLIC ACT NO. 8748

Pursuant to the powers vested in me under Republic Act No. 7916, otherwise known as the Special Economic Zone Act of 1995, as amended by Republic Act No. 8748 and upon recommendation of the Board of Directors of the Philippine Economic Zone Authority, **I, RODRIGO ROA DUTERTE**, President of the Philippines, do hereby create and designate a building, subject to the provisions of Republic Act No. 7916, as amended, its Implementing Rules and Regulations, Resolution No. 00-411 (s. 2000), as amended by Resolution Nos. 11-066 (s. 2011) and 15-240 (s. 2015), and Resolution No. 15-715 (s. 2015) of the Board of Directors of the Philippine Economic Zone Authority, as an Information Technology Center to be known as **Robinsons Cybergate Naga**, with a gross floor area of **Six Thousand Three Hundred Sixty-Seven and $\frac{11}{100}$ square meters (6,367.11 m²)**, which stands on several parcels of land located at Naga Diversion Road corner Almeda Highway, Barangay Triangulo, Naga City containing an aggregate area of **Twenty Four Thousand Eight Hundred Seven square meters (24,807 m²)**, more or less, as defined by the following technical description:

Lot 1126-C-4-A, Psd-269369

A parcel of land covered by TCT No. 086-2014002588 (Lot 1126-C-4-A of the subdivision plan [LRC] Psd-269369 being a portion of Lot 1126-C-4, Psd-05-000792, LRC Rec. No. F. Patent), situated in the Barangay of Concepcion Pequeño, City of Naga, Province of Camarines Sur, Island of Luzon.

A parcel of land covered by TCT no. 086-2014002592 (Lot 1126-D of the subdivision plan, Psd-68254 being a portion of Lot 1126 on the Cadastral Survey of Naga, LRC Rec. No. F. Patent), situated in the Barangay of Concepcion Pequeño, City of Naga, Province of Camarines Sur, Island of Luzon.

Bounded on the SE., along line 1-2 by Lot 1126-C, of the subdivision plan; on the SW. and NW., along lines 2-3-4-5-6-7 by Lot 1127 of Naga Cadastre; on the NW., along line 7-8 by Lot 1126-E; on the NE., along line 8-1 by Lot 1126-F, both of the subdivision plan.
