PROCLAMATION NO. 1175

**CREATING AND DESIGNATING SEVERAL PARCELS OF LAND, LOCATED
IN BARANGAYS PALLOCAN SILANGAN AND GULOD LABAC,
BATANGAS CITY AS SPECIAL ECONOMIC ZONE (INFORMATION
TECHNOLOGY PARK), PURSUANT TO REPUBLIC ACT NO. 7916, AS
AMENDED BY REPUBLIC ACT NO. 8748**

Pursuant to the powers vested in me under Republic Act (RA) No. 7916 or the "Special Economic Zone Act of 1995," as amended by RA No. 8748, and upon the recommendation of the Board of Directors of the Philippine Economic Zone Authority (PEZA), **I, RODRIGO ROA DUTERTE**, President of the Republic of the Philippines, do hereby create and designate several parcels of land located in Barangays Pallocan Silangan and Gulod Labac, Batangas City, as a Special Economic Zone (Information Technology Park), to be known as **The Forum at Pontefino Estates**, subject to the provisions of RA No. 7916, as amended, its Implementing Rules and Regulations, PEZA Board of Directors Resolution No. 00-411 (s. 2000), as amended by Resolution Nos. 11-066 (s. 2011), 15-240 (s. 2015), 17-472 (s. 2017) and Resolution No. 17-606 (s. 2017), as amended by Resolution No. 19-224 (s. 2019), with an area of **Forty-Two Thousand Five Hundred Sixty-Seven square meters (42,567 m²)**, more or less, as defined by the following technical description:
