PROCLAMATION NO. 1112

CREATING AND DESIGNATING SEVERAL PARCELS OF LAND,
LOCATED AT NATIONAL ROAD PUROK 9, BARANGAYS CABUG
AND MAANAS, MUNICIPALITY OF MEDINA, PROVINCE OF
MISAMIS ORIENTAL, AS AN AGRO-INDUSTRIAL ECONOMIC ZONE,
PURSUANT TO REPUBLIC ACT NO. 7916, AS AMENDED BY
REPUBLIC ACT NO. 8748

Pursuant to the powers vested in me under Republic Act (RA) No. 7916 or the "Special Economic Zone Act of 1995," as amended by RA No. 8748, and upon the recommendation of the Board of Directors of the Philippine Economic Zone Authority (PEZA), I, **FERDINAND R. MARCOS, JR.**, President of the Philippines, do hereby designate several parcels of land, located at National Road Purok 9, Barangays Cabug and Maanas, Municipality of Medina, Province of Misamis Oriental, as an Agro-Industrial Economic Zone, to be known as **Allcoco Development Corp Industrial Estate** subject to the provisions of RA No. 7916, as amended, its Implementing Rules and Regulations, PEZA Board Resolution No. 07-232 (s. 2007) and Resolution No. 17-486 (s. 2017), with an aggregate area of **One Hundred Ninety-One Thousand Three Hundred Eighty-Four square meters (191,384 m²)**, more or less, as defined by the following technical description:


