

NOTICE



Sirs/Mesdames:

Please take notice that the Court, First Division, issued a Resolution dated September 17, 2014 which reads as follows:

"G.R. No. 208409 (People of the Philippines v. Pedro Decrito y Provido). - After a judicious perusal of the records, the Court resolves to **DISMISS** the appeal for failure to show that the Court of Appeals (CA) committed any reversible error in affirming the conviction of accused-appellant Pedro Decrito y Provido for the crime of Parricide defined and penalized under Article 246 of the Revised Penal Code (RPC).

**WHEREFORE**, the Court **ADOPTS** the findings of fact and conclusions of law in the April 26, 2012 Decision<sup>1</sup> of the CA in CA-G.R. CR-H.C. No. 05073 and **AFFIRMS** said Decision finding accused-appellant Pedro Decrito y Provido **GUILTY** beyond reasonable doubt of committing the crime of Parricide defined and penalized under Article 246 of the RPC, with **MODIFICATION** in that he is sentenced to suffer the penalty of reclusion perpetua without eligibility for parole, and ordered to pay the following amounts: (a)  $\clubsuit50,000.00$  as civil indemnity; (b)  $\clubsuit50,000.00$  as moral damages; (c)  $\clubsuit25,000.00$  as temperate damages; and (d)  $\clubsuit30,000.00$  as exemplary damages, in order to conform with prevailing jurisprudence.<sup>2</sup> In addition, legal interest at the rate of six percent (6%) per annum shall be imposed on the monetary awards from the date of the finality of this judgment until fully paid.

SO ORDERED."
