NOTICE

Sirs/Mesdames:

Please take notice that the Court, First Division, issued a Resolution dated October 13, 2014 which reads as follows:

"G.R. No. 213461 (Delia H. Reuyan v. Dr. Livey J. Villarin and Engr. Evan Lagura). - After a judicious review of the records, the Court resolves to DENY the instant petition and AFFIRM the June 17, 2014 Resolution of the Court of Appeals (CA) in CA-G.R. SP No. 04934 for failure of Delia H. Reuyan (petitioner) to show that the CA committed any reversible error in holding that she was not denied due process of law when she failed to receive a copy of the CA's Minute Resolution dated May 3, 2013.

It is well-settled that until a counsel's dismissal or withdrawal is formally made, any court record sent to her binds the client, despite an internal arrangement between them terminating their professional relationship.² Here, the petitioner's counsel, Atty. Jasmin C. Guiuo-Diaz, failed to file a formal withdrawal of appearance with respect to the instant case. As such, she remained as petitioner's counsel on record and consequently, the notices sent to her binds her client. With this representation, it cannot therefore be said that petitioner's due process rights had been violated. Consequently, the July 29, 2013 Resolution of the CA dismissing petitioner's petition had attained finality.

The petitioner is hereby **DIRECTED** to **SUBMIT** within five (5) days from notice hereof, a soft copy in compact disc, USB or e-mail containing the PDF file of the signed petition for review on certiorari and annexes pursuant to the Resolution dated February 25, 2014 in A.M. Nos. 10-3-7-SC and 11-9-4-SC.

The Cash Collection and Disbursement Division is likewise hereby **DIRECTED** to **RETURN** to the petitioner the excess amount of P1,270.00 paid
