

NOTICE

Sirs/Mesdames:

Please take notice that the Court, First Division, issued a Resolution dated November 10, 2014 which reads as follows:

"G.R. No. 213793 (Raul Dulay and George Taculog v. Sawasdee* Marketing Corporation/Raphael Li Chua). - The petitioners' motion for an extension of thirty (30) days within which to file a petition for review on certiorari is GRANTED, counted from the expiration of the reglementary period.

After a judicious review of the records, the Court resolves to **DENY** the petition and **AFFIRM** the February 28, 2014 Decision¹ and July 25, 2014 Resolution² of the Court of Appeals (CA) in CA-GR. SP No. 130572 for failure of Raul Dulay and George Taculog (petitioners) to sufficiently show that the CA committed any reversible error in finding that they were not constructively dismissed by Sawasdee Marketing Corporation (respondent).

As correctly ruled by the CA, petitioners failed to prove that they were constructively dismissed by respondent. It is well-settled that factual findings of the labor tribunals, when affirmed by the CA, are generally accorded not only respect, but even finality, and are binding on the Court, as in this case.

The petitioners are hereby required to **SUBMIT** within five (5) days from notice hereof, a verified declaration of the petition for review on certiorari and annexes pursuant to A.M. Nos. 10-3-7-SC and 11-9-4-SC.


