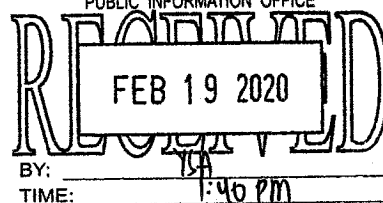

Please take notice that the Court, Third Division, issued a Resolution dated **January 22, 2020**, which reads as follows:

“A.C. No. 12613 [Formerly CBD Case No. 17-5270] (In Re: CA-G.R. SP No. 03161 Aklan Electric Cooperative Inc. v. National Labor Relations Commission, et al. against Atty. Remo T. Alindato) – The Court **NOTES** the letter dated August 28, 2019 of Atty. Randall C. Tabayoyong, Director for Bar Discipline of the Integrated Bar of the Philippines Commission on Bar Discipline, transmitting to this Court the documents pertaining to this case.

The August 29, 2018 Notice of Resolution,¹ of the Board of Governors (Board) Integrated Bar of the Philippines (IBP) is **NOTED**.
