THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. The Lakewood Municipal Hospital in the Municipality of Lakewood, Province of Zamboanga del Sur, is hereby

expanded and upgraded from a ten-bed capacity municipal hospital into a twenty-five bed capacity capacity district hospital, to be known as the Lakewood District Hospital.

SEC. 2. The amount necessary to carry out the provisions of this Act shall be included in the General Appropriations Act of the year following its enactment into law and thereafter.

SEC. 3. This Act shall take effect upon its approval.
